The scope of this ISO/IEC 27701:2019 certification is as follows:

Nexthink cloud-based digital employee experience management SaaS solution including all product components as well as the services used to deliver these applications. For PIMS scope, Nexthink acts as a Data Processor for Personal Data that Nexthink processes on behalf of its customers when providing services through the Nexthink cloud-based digital employee experience management SaaS solution. Nexthink Products share the same common control framework.

The departments in scope include Product management, Engineering, Technical services, Finance, People & talent (HR), Information Technology, Legal, Sales operations and Security.

The Privacy Information Management System is centrally managed out of Centre Malley-Lumières, Chemin du Viaduc 1, 1008, Prilly, Switzerland. The scope mentioned above applies to the following locations:
